Pursuant to provisions of Section 2907 and 2908 of Ordinance No. 274-72 the Director of Building Inspection has determined that the kind of work to be done may generate noise that causes significant disturbance during the permit hours. The work may cause less traffic and safety problems at night than during daytime. Therefore being in the general public interest hereby grants permission revocable at his will for **mobilization of a mobile crane, delivery of modular units and setting of the modular units.**

- > This permit shall be valid for the dates and times below only.
- > Hours: Sept 08th to 10th = 12:00am – 7:00am
- > Hours: Sept 13th to 15th = 12:00am – 7:00am
- > Equipment List: Delivery Trucks with Modular Units, Light Towers 3 each, 1 Mobile Crane – 350 Ton All Terrain Crane, Rough Carpentry Small Tools
- > All light towers must be directed away from neighboring buildings.
- > All significant equipment shall be provided with proper mufflers and acoustical shrouds.
- > Excessive noise from handling tools and loud conversation shall be held at minimum.
- > All other required permits shall be obtained.

The permittee, by acceptance of this permit, agrees to indemnify, hold harmless, and assume the defense of the City and County of San Francisco from and against any and all claims, demands, and actions for damages resulting from operations under this permit, regardless of negligence of the City and County of San Francisco.

The permittee, by acceptance of this permit, agrees to compensate the City and County of San Francisco in full for all damage to property of the City and County of San Francisco, or to public property under its jurisdiction resulting from operations under this permit, regardless of negligence of the City and County of San Francisco.
